Terms & Conditions of the 2020 Can/Am Clydesdale Extravaganza Sale

- If an entry is to be accepted the original registration papers, signed transfer and if applicable breeding information and entry fee must be sent with each entry form by the catalogue deadline, March 31st, 2021. It is the sole responsibility of the consignor to furnish these papers, if you wish your horse entered into the sale catalogue.
- GUARANTEES on horses are strictly between buyer and seller.
- Terms of the sale are cash, and payment in full must be made immediately after the sale. A cheque is acceptable from properly identified individuals. We will accept Visa or debit cards. A 4% charge to the buyer on all credit card purchases. Pay the sale staff in all cases. IN NO CASE shall any part of purchase money be paid by buyer to the consignor as such payments will not be regarded as valid or entitle buyer to release the horse. On final payment for a horse the cashier will issue a release form of which must be presented to the barn manager for release of the horse from barn. Buyers do not lose these release forms!
- The sale management reserve the right to reject an animal already entered into the sale catalogue if the animal arrives in poor quality or condition. Their entry fee will be forfeited.
- Reserve bids on horses must be established before the horse goes through the sale ring, to the sale committee.
- If your horse is not sold the flat fee of \$350.00 US must be paid to the office, before the original pedigrees will be released to the consignor. **NO HORSE** will be released from the barn without a release form.
- CATALOGUE DEADLINE: March 31st, 2021
- Each horse selling must be left with a halter & lead rope for the new owner. It is the consignor's responsibility to have the horse up to the ring in sale order.
- All registered animals will be transferred to the new owner by the Can/Am Sales staff. To enter a horse in this sale you should be a Clydesdale or Shire member if you are not, you will be charged appropriately with regards the transfer fee.
- You must take your own horse through the sale ring. Horses sell in hip tag order, unless otherwise stated. You are responsible for your horse while on the Michiana Event Center (MEC) property.
- All horses must go through the sale ring. **ADSOLUTELY NO PRIVATE SALES!** Any horse on premise during sale days will be charged an entry fee.
- Tack Sale Consignments Absolutely no junk, as we are looking for larger show items only, we hope to keep the selling of the tack to a minimum of 2 hours only. The commission rates are as follows: 20% on individual items from \$ 1.00 to \$500.00
 - 10% on individual items from \$501.00 to \$3,000.00
 - 5% on individual items over \$3,000.00
 - The consignor is responsible to declare the reserve bid on any item before the sale starts. No reserves will be taken for items under \$200.00. If your reserve is less, it is your own responsibility to bid your item in. The above commission rate will be charged on the final bid. Advertising will be free on our web-site and will be posted with pictures right up until Catalogue deadline date. All tack must be booked in by Tuesday, May 25th 12 Noon.
- Horses may arrive to the Michiana Event Center as early as Tuesday, May 25th at 9:00 A.M. and stalls will be allocated. With your entry fee you receive one box stall with 1 bag of shavings already in it, per horse. All other shavings must be purchased at the MEC Center at a cost of \$8.00 per bag. Consignors are NOT allowed to use their own shavings and NO STRAW allowed. Hay and Feed can also be purchased at the MEC Center and the breakdown of these costs will be available shortly. If you wish any extra stalls for displays or feed stalls they are available at an extra cost of \$75.00 US per stall.

- Health Paper Requirements: Individual interstate health papers and original negative Coggins papers must accompany the horses and are required by all States and Canada. Each horse must have an individual and updated Coggins test. They must be signed and dated by a licensed Veterinarian. Coggins papers are not required on foals that are nursing and under 5 months of age. Foals do however need their own health papers. We will have a Federal Vet in the office during the sale to do all the paperwork on those animals that will be going to Canada. Canadian buyers will be responsible for paying a fee for each export paper written by the Federal Vet.
- In-Transit Animals In-transit animals will be allowed at the MEC Center but stalls must be booked for each horse at a cost of \$100.00 US. In-transit stalls must be reserved and paid for ahead of the sale by contacting Margo Carson (519) 292 1221. All in-transit horses must be looked after by the person in charge. These horses must also have the same Interstate Health Papers and Coggins as any sale horses.
- Statements regarding soundness, breeding dates etc. will be made from the auction stand by the owner's description. When the gavel falls you assume full ownership & responsibility of the horse. The BUYER has a responsibility to examine a horse carefully before they bid on it. If you buy a horse on impulse without inspecting it before you bid you may expect to find some surprises. IN THAT CASE YOU STILL OWN THE HORSE!! Once you bid on a horse you are indicating that you have checked it out enough to satisfy yourself and no one else is responsible. After the horse leaves the premises there will be no return on the horse.
- All horses will be sold on the information in the footnotes of which were furnished by the consignor. The Sale Staff and Auctioneer is neither responsible for any footnotes or for any warranties concerning the horse catalogued.
- LIABILITY: Everyone on the sale premises is cautioned to exercise reasonable care. We urge all to keep clear of the sale ring where the horses are being shown, and upon failure to do so, and resultant injury therefrom, Carson Farms & Auction Services Ltd, or any member of the sale committee handling the sale disclaims any and all liability. You enter these premises at your own risk, caution must be taken.
- By-Law Anyone purchasing at Auction and issuing a N.S.F. cheque is committing an act of fraud and will be dealt with according.
- The highest bidder will be the buyer. If a dispute arises between 2 or more bidders, the horse shall immediately be put up again for advance bids. If there is no advance, then the horse shall go to the person from whom the auctioneer recognized the last bid. The auctioneer reserves the right to reject any and all bids.

Term & Conditions for "AUCTION BY ABSENTEE SECTION"

Horses are entered into the catalogue & will be sold by our auctioneers to our captive Clydesdale Breeder & Pleasure Horse Buyers, without the horses coming to the sale. They are simply sold from their pedigrees, footnotes, pictures and/or videos supplied by the seller and will be sold once the live auction section has been completed. For Canadian Clydesdale enthusiasts that are still unsure about any border restrictions and regulations we will be setting up at David Carson's Auctions on both Sale Dates for any Canadian Horses selling in this section to be viewed and ready to be shipped to the New Buyer in the States, if that is the case, for a set fee. (Further details about this will be posted closer to the time, depending on restrictions.

- The above entry form will be filled out and must be submitted by the catalogue deadline of March 31st, 2021. However, the entry fee for this section is NOW \$300.00 US or \$400.00 Canadian per entry with 6% commission if your horse sells. If the horse doesn't sell. You have paid your entry fee and there will be no further cost.
- Full pedigree information, footnotes, entry fee & pictures and/or video must be submitted to us by the March 31st Deadline to ensure, your animal is entered in the catalogue.
- However, if you are supplying an additional videos or pictures this will be taken right up until February 28th and will be shown on a TV Screen at the auction.
- Your horse is not required to come to the auction so no additional costs are required for transporting
 your animal. Therefore, mares who are heavy in foal or have young foals at side don't need the extra
 stress of being transported.
- As a seller you will hold the horse for at least a 30 day period to allow the new buyer to arrange trucking and are responsible for preparing any paperwork that is required by the buyer to take your animal home. i.e. Coggins and export papers.
- As the buyer they are responsible for knowing exactly where the animal is located, as all the trucking expenses are at the new buyer's expense. The animals will be paid for immediately once the sale is over, just like any other animal. The Can/Am Sales staff will hold this check until we have confirmation that the horses has been delivered to their new homes. This must happen within the 30 day period.
